Good morning.

I have credible reports of two phone calls from Jeff Price to Tom Price on Christmas morning and Christmas evening. Staff answers the phone at the residence and takes the cordless phone to Tom. Apparently, Jeff is getting his father worked up. Tom starts yelling about his money and other family issues. It takes the staff an hour or more after a call from Jeff to get Tom calmed down. After a couple hours, Tom does not remember any of it.

Jeff is wasting his time. The seeds he is trying to plant are not sticking in Tom's mind for any significant amount of time. I think it's abuse. It has to stop. If this continues, Jeff will not be seeing or talking to his father.

I am copying Caroline Dawson at AgeWise because Jeff is interfering in the work she has been hired to do.

I also had a call from Melanie at Clover Care. Tom's Part D coverage has lapsed for non-payment. This was an auto pay on the Discover card that I cancelled. Jeff of course did not say anything about that until the coverage lapsed. I have submitted my authority documents to P&G Retirement and benefits. When they figure out that I have authority to act for Tom Price, I will get the coverage reinstated. I will also inquire with them about the address of record that they have, how many notices were sent to that address, and we will probably need to discuss why Jeff did not notify you or me about the mail he was receiving for his father.

I am pretty sure that all of Tom's mail is going to Jeff. I will need tax reporting for the income tax returns. Whatever other mail Jeff is receiving should be sent to me also.

Jeff has shown me in every way he can, exactly what kind of person he is. I am not complaining about that. His poor behavior is making the process of administering a guardian and conservatorship much more time consuming and expensive than it needs to be. If this continues, we will need address how the fees and expenses for this matter are assessed.
