My dad (Tom Price) is moving from Benton House to "Clover Care Home." tomorrow. Their address is 6320 Zarda Dr., Shawnee, KS 66226, and their phone is 913-991-2605.

I have worked out Tom's last day at the Benton House to be Monday, which may have to be moved to Tuesday due to the delay in removing some items. I take it you will work with them for any reimbursement? Also, would you stop paying the Benton House and begin paying Clover Care Home? Also, I assume you will contact Westchester for his final billing; am I correct?

Regarding Genworth Long-Term Care, I am very familiar with the policy. I worked with Genworth in 2016 for assistance with my mother. Good morning.

It sounds like what I really need to do is contact Clover Care and make an appointment to sign the admission agreement and make arrangements to pay.

The current care bill has been requested about 10 days in advance of the due date to allow for the check to be cut and mailed. I know that you are all aware, as a Temporary Conservator, my access to funds is delayed. I will see what I can do.

Who is my contact at Clover care? Did Jeff Price sign a contract or admission agreement? I don't mind requesting refunds for Benton house as soon as I know that Mr. Price has vacated. Please let me know when he vacates. Do I need to attend a walk through inspection at Benton? I am sure that Westchester will be happy to give me a bill for Mr. Price's care. Are we talking about Westchester Village of Lenexa at 8505 Pflumm?

With respect to the Genworth claim, I am sure that I can get the people at Westchester to provide his date of admission, current diagnosis and current care needs. I do not need any help from Jeff Price to make a Genworth claim.

I do mind when Jeff Price, or anyone else, interferes in the business of the Conservatorship. Jeff asked me specifically if he could serve as Co-Conservator, and I specifically declined his assistance as Co-Conservator. If Jeff Price continues to secure services for his father, attempts to bind the Trust, the Conservator or the Conservatorship, and commits to a course of action that he knows can't be met, it is a problem. Allowing him to continue the Genworth claim process for me, because he is so knowledgeable and capable, will not relieve me of the responsibility of making sure that it gets done. Involving Jeff makes my job more difficult. If he and I provide conflicting information, the claim process will bog down.

If Jeff does not remember asking me if he could serve as Co-Conservator, he needs to be reminded of that conversation. He needs to stay in his lane. He needs to resist accessing

Conservatorship funds and Trust funds and credit in his father's name. If this is going to be a problem going forward, please advise.

If there are any other issues connected to the proposed move that need to be addressed a little advanced planning would be refreshing. I am specifically talking about movers, expenses, supplies, expense reimbursement, toilet paper, and other incidentals.

I have an appointment this morning until about 11AM. I have a client at 2PM for about an hour. Otherwise, I am generally available.
